PURPOSE: The purpose of this procedure is to summarize regulations and provide necessary forms for personnel hunting waterfowl at Naval Base Ventura County (NBVC).

- 1 **APPLICATION:** This procedure applies to all personnel hunting waterfowl at the Point Mugu location of NBVC. All hunters will review/read and be familiar with this SOP.
- 2 **PROCEDURE:** Submit hunting requirements to the Environmental Division. The office is located in Building 632 on the corner of Laguna Road and Ronald Reagan Blvd) at Point Mugu. The office is open from 0700-1700 Monday through Friday, and there are also designated drop-off and pick-up boxes on the back of Building 632 (Attachment 1). - b. In addition to this document, an annual notice will be published listing shooting times, current fees, and waterfowl committee members to contact if additional information is desired.

CHAPTER 1 - NBVC HUNTING REGULATIONS

1. General Requirements. Hunting of waterfowl is authorized aboard NBVC Point Mugu in accordance with the schedule published in the annual notice during the approved California and federal hunting season as set forth by the California Department of Fish and Game and the U.S Fish and Wildlife Service. All personnel hunting waterfowl must comply with state and federal licensing requirements.

2. Admittance to NBVC for Hunting


- a. Personnel who have valid personal and vehicle base access credentials should arrive for entry no earlier than two hours before scheduled shooting.
- b. Hunting personnel who do not otherwise have base access are admitted only as guests of those personnel, (e.g., sponsors) with proper identification. Sponsors must physically accompany guests at all times while on the installation if the guest does not have a base badge. Hunters must have in their possession a Waterfowl Hunter's Access card (Attachment 3), government issued photo identification, and valid California hunting license with state and federal waterfowl stamps.
- c. All hunters will present their Waterfowl Hunters Access Card with their ID to the gate guard upon entry.

- d. An adult sponsor (18 years or older), with a valid state hunting license and federal waterfowl hunting stamps, shall accompany dependent children under the age of 18 years old in the hunting area at all times.

3. Safety

- a. Shotguns must be cased, unloaded, and placed in a locked trunk, compartment, or vehicle when not in use.
- b. Unauthorized patrons are not allowed in the blinds at any time. Any non-shooting guest must submit a blind request with the non-hunting intention noted in the remarks section of the blind request.
- c. Many hunting blinds are located within the Explosive Hazard Area; therefore, there may be instances when the area must be cleared in the interest of safety. Inherent with acceptance of a blind assignment is the understanding that when requested to vacate by any Security Guard, CDO, Weapons personnel, Environmental personnel, or member of the Waterfowl Hunting Committee, hunters will immediately comply. All hunters must read, sign, and return the Hazard Safety Brief, Attachment 10, prior to being assigned a blind.
- d. No alcoholic beverages are permitted in the hunting areas.
- e. Shooting is prohibited within 500 feet of buildings, utility and communication lines/cables, aircraft and aircraft movement areas, or personnel.
- f. No firearm will be discharged within 600 feet of an ammunition bunker or toward any weapons production facility with windows within 1,200 feet. Hunters will not trespass within the perimeter fence of the ammunition bunkers.
- g. In the event a downed bird is inside the fence of the bunkers call the NMCDO at 805 320-4873 to coordinate access. Guns can be taken into the magazine area, but the gun must be unloaded with the action open at all times within the fenced area. Also, all flame and spark producing devices must be left at the gate. To minimize the loss of time to the ordnance or security escort, have the bird well spotted before entering so that it can be retrieved expeditiously.
- h. Firing from a vehicle or roadway (paved or unpaved) or while walking to and from a blind is prohibited (unless retrieving an injured duck).
- i. All blinds are closed after 0700 on Wednesdays. Furthermore, closure of blinds 18, 39, 41, and 70-75 blinds on weekends is treated differently depending on the following circumstances:
 - (1) In order to be assigned these blinds the hunter must have a current email address listed on his/her registration and must check it after Friday at 6PM for weekend notices. In the event flight operations on the main runway 03/21 take place before 10 AM, hunters will be notified and must vacate these blinds.
 - (2) If the hunter does not have a 2-way radio checked out from Air Operations, these blinds are closed to shooting after 10 AM on Saturday and Sunday. In the event flight operations on the main runway 03/21 are scheduled to take place on the weekends before 10 AM, hunters will be notified the Friday prior and expected to vacate these blinds by the time specified and remove any temporary blind materials.
 - (3) If the hunter has checked out a radio from Air Operations, the hunter shall follow the instructions provided by the Pt. Mugu Control Tower. If the hunter is not able to remain in radio contact with Pt Mugu Control Tower, the guidance in (1) above applies. Permission to hunt all day or intermittently throughout the day in affected blinds is contingent on hunters remaining in contact with Pt Mugu Control Tower, listening to communications and, if directed, vacating the blind with

all temporary blind materials. These hunters with radios must notify the tower when they are vacating the blind for the day if it is past 10 AM. See Attachment 10 for radio checkout info.

- j. Hunters need to be aware of aircraft operations. If an aircraft is arriving or departing, they should not shoot from the blinds adjacent to runway, i.e. 16-18, 39, 40, 41, 70-75, as firing could put more birds in the air and create an air strike hazard for departing/arriving aircraft.
- k. Hunters need to remain off runway/taxiway surfaces.
- l. Hunters should reduce and attempt to avoid all direct contact with water and sediment to reduce potential exposure to contaminants that may be in water or soil, such as historic DDT or recent runoff of pesticides from adjacent agricultural areas. It is best to wear waders. Hunters should thoroughly wash any skin or clothing which may have come into contact with water or sediment.


4. Firearms

- a. All hunters, including guests, are required to fill out and turn in shotgun registration forms (Attachment 4) prior to the submission of Blind Request Forms. The Waterfowl Committee shall be responsible for compiling and providing gun registration data to NBVC Security and NBVC Environmental. NBVC Security will not accept Hunter Shotgun Registration Forms at the gate. Only one shotgun is allowed onboard any given day.
- b. Only shotguns of 10, 12, 16, or 20 gauge and incapable of holding more than three shells in the magazine and chamber combined, are authorized.
- c. All hunters are limited to 50 shot shells while in their blinds and are required to retrieve and remove from the hunting areas, all expended hulls and wads. Keep additional shells in vehicles and retrieve as necessary.
- d. Only approved non-lead shot (steel, bismuth, and tungsten, etc.) is authorized for waterfowl hunting.
- e. Authorized hunters who reside off base and sponsored guests are required to register their firearms during the period(s) that their approved blind assignment is valid. Personnel residing on base must follow current NBVC instructions regarding weapon storage in base housing.
- f. Hunters must maintain positive control of firearms at all times. If weapons are left unattended to drop/pickup gear (including along the road) that hunter will have his/her base privileges removed.

5. California Hunting License. All personnel desiring to hunt waterfowl aboard NBVC Point Mugu, must present or submit a copy of their California hunting license with a Duck (Waterfowl) Validation, Harvest Information Program (HIP) Survey validation, and federal duck stamp to the Environmental Division Waterfowl Rep or Waterfowl Committee Rep.

6. Waterfowl Hunting Written Test. All personnel (including guests) desiring to hunt waterfowl aboard NBVC Point Mugu, must take and pass a written test that demonstrates that the hunter has read and is familiar with this procedure and the State of California waterfowl hunting regulations. The test includes a special section on species identification. The hunter must score at least 85 percent to pass each section of the test. The test may be taken at home to complete. The completed test may be emailed or returned to the NBVC Environmental office.

7. Registration Requirements. A military affiliated identification must be presented in person the first time registering to establish eligibility for hunting. A base hunting area tour must also be conducted before hunting (guests excepted). All hunters (including guests), must submit their shotgun registration form (Attachment 4) as

well as DD Form 2760 (Attachment 8 – but please use fill-in form on Internet). Be sure to include middle initial on forms. Guests will have their ID and hunter access cards checked at the gate.

8. Hunting Fees. The yearly waterfowl hunting fee will be listed in the annual notice.

9. Access Card. On completion of all requirements, the hunter will be issued a hunter's access card. The access card will be used to verify the eligibility of the hunter and should be kept on the person when hunting. Hunters must also present the access card upon request by committee members, NBVC security, or CDFW game wardens.


10. Waterfowl Bag Record. All hunters are required to fill out and turn in the completed waterfowl bag record printed on the back of each blind request for each day of hunting. Completed waterfowl bag records for each hunt are to be turned in at the Environmental Division or the designated drop box by 1100 on Monday morning before the following week's assignments are made. If a hunter does not hunt on an assigned day, the waterfowl bag record must still be turned in and should state that fact. This recording system monitors trends in the waterfowl population and aids in the management of our blinds on base.

11. New Hunters to NBVC. Any hunter that has never hunted aboard Pt. Mugu is required to view the NBVC waterfowl hunting video, located at: <http://www.youtube.com/watch?v=XfxaVgEUMLo&feature=youtu.be> and to take a one-hour tour of the base. Questions will be asked about the video during the tour to ensure compliance. Guests are not required to take the tour.

CHAPTER 2 – NBVC HUNTING SEASON AND AREAS

1. Pre-Season Blind Repairs. The Waterfowl Hunting Committee shall work through NBVC Environmental to gain all required permits for the construction or major repair of all hunting blinds and bridges that are within jurisdictional wetlands. This will ensure protection against potential impacts to resources of the state coastal zone and federal and state listed threatened or endangered species. As it is a violation of our Biological Opinion, dogs are not allowed to accompany committee members while checking blinds in need of repair nor during the actual repair. Dogs are only allowed to accompany committee members and hunters while hunting. The Waterfowl Hunting Committee shall propose repair efforts by the end of August. Necessary permits or consultation will include but are not limited to the following:

- a. Clean Water Act, Section 404;
- b. Clean Water Act, Section 401;
- c. Rivers and Harbors Act, Section 10;
- d. Coastal Zone Management Act;
- e. Endangered Species Act, Section 7;
- f. Marine Mammal Protection Act;
- g. Federal Noxious Weed Act of 1974;
- h. Construction Programs on Military Reservations (Sikes Act);
- i. Fish and Wildlife Coordination Act; and
- j. National Environmental Policy Act.

2. Hunting Blinds

- a. Waterfowl hunting is allowed only in authorized blinds and shooting locations as depicted in Attachment 5.
- b. Waterfowl hunting in Mugu Lagoon between Laguna Road and M avenue is prohibited.
- c. Decoys shall not be set out earlier than two hours before an assigned day of shooting except in blinds 10-14, where they may be set out the night before. Decoys used during hunting periods must be picked up immediately after the shoot is completed unless the hunter is assigned the same blind the next morning.
- d. Blinds 11 through 17 and the Calleguas Creek area are reserved for “decoy and call” use and require the use of at least one dozen decoys. Hunters in these blinds will cooperate to the maximum extent possible, making sure that they allow the birds to fully work the decoys. Do not shoot at far ranging birds that are working the spreads of a neighboring blind. This requirement is waived on Wednesdays.
- e. Blinds 11 through 14 may only be accessed via boat through the tidal creeks. Blind 10 shall normally be accessed via the COTAR pad to the west. Otherwise it will be accessed as close as possible by boat.
- f. Clean or dress waterfowl only in the established messes or quarters, not in the field.
- g. Hunters are held responsible for the general cleanliness of their assigned blinds and the surrounding area. They will police the area of expended ammo and wads, particularly in and around buildings and parking areas, and remove all debris from the blind areas. Failure to police assigned blinds can result in revocation of future hunting privileges.
- h. Bright colored clothing, e.g., yellow rain slickers, red coats, shirts or caps are not permitted.
- i. Blinds 18, 39, 41, and 70-75 are closed after 10 AM on Saturday and Sunday unless you have checked out a radio from Air Ops (See map on Attachment 10) and are in continual contact with the Pt Mugu control tower. In order to be assigned these blinds the hunter must have a current email listed on his/her registration and must check it after Friday at 6PM for weekend closure notices. In the event flight operations on the main runway 03/21 take place before 10 AM, hunters will be notified by email and must vacate these blinds.

3. Special Hunts: Calleguas Creek. Hunting is allowed on Saturdays only in designated locations along Calleguas Creek, in the eastern arm area of Mugu lagoon. This area is known as the eastern shooting area or ESA. A map is included in Attachment 6. Assignments are divided into morning (start-11:30) and afternoon (1200-stop) hunting periods. Please list “ESA xx AM or ESA xx PM on assignment requests as is done for blind 16. One-half hour is allowed for decoy pick up, transit and incoming hunter setup. Hunters are assigned one of the blind locations defined by the placement of marked stakes. These are located on the hunting area map. In order to hunt in this area, hunters must bring their own temporary blind since there are no permanent blinds allowed in the area.

- a. All hunting is done from portable blinds on the shore. There is no hunting from the open sand bars.
- b. Use of a boat is required for ALL ESA locations due to deep water with high tides. Personnel desiring to hunt this area must indicate on their request chit whether or not they have a boat. Dogs alone are not sufficient. ESA area “A” may only be accessed by boat upstream. Boats MAY NOT be launched from the corner of Las Posas Rd and 13th Street.
- c. Tidal movement can be significant in this area. It is strongly encouraged that each party carefully consult a tide chart for the predicted times and rain forecast to estimate the severity of additional water flow.

4. Shooting Periods

- a. Hunters are required to locate the assigned blind before the day of shooting. Hunters should be in their blinds at least 30 minutes before shooting time. If this is not possible, hunters shall not proceed into the area until 30 minutes after shooting time. Compliance is mandatory to prevent latecomers from jeopardizing the potential success of those hunters already in their blinds.
- b. Hunting is permitted only on authorized hunting days listed in the Environmental Department Annual Information Publication.


5. Assignment of Blind 16. Blind 16 will be divided into “AM” and “PM” like the ESA assignments. List each of the desired period(s) accordingly on your blind request. Additionally, blind 16 has bird spikes installed. These may be folded down away from the inside the blind so they are out of the way during shooting. If they are folded down they **MUST** be pivoted back up prior to departure.

6. Use of Dogs

- a. Dogs are only allowed to accompany hunters during the hunting season, not during blind repair.
- b. Restrain dogs while proceeding to and from the blinds. Do not let them run wildly particularly when proceeding to / from blind 10.
- c. During shooting periods, confine dogs to within three yards of the blinds except when retrieving ducks. The use of dogs to help find and return downed birds is encouraged.
- d. Dogs are not allowed in shooting areas 40 and 41.
- e. The only exception to the above is that dog training may be accomplished only during the hunting season on hunting days in Blind 22, and ESA E. Limited dog training will be allowed at these locations for the purpose of providing the dog with exposure to the terrain, lagoon and water entries at each location. The amount of training must be incidental to hunting effort at the blind

7. Use of Boats.

- a. Boats, kayaks, canoes should be limited to 4 person sized vessel.
- b. Use oars or electric motor to power vessel. No gas engines.
- c. Boats can be kept on base during hunting season (preferable). Haul boats out on shore and secure to avoid tides taking boats out into the channel. Boats found adrift or unserviceable may be impounded or disposed of if they appear to be abandoned and the owner cannot be contacted.
- d. ALL boats entering NBVC for the first time of the season must be cleaned of all riders, parasites, or other biologic material clinging to the trailer, boat hull, anchor / lines, bilge, or any other compartment, surface or structure that may hold or contain a fragment of vegetation or tiny invasive invertebrate.
- e. Use boats only to proceed expeditiously to and from the blinds and for retrieving downed birds, being careful not to interfere with hunting in adjacent blinds. There is no hunting from the boats.
- f. Boats must also have additional identifying numbers, names, or letters which also must be recorded on the hunter’s registration form in case it is found damaged or adrift due to floods, in order that the owner may be contacted.

8. Parking Areas


- a. Parking for the 10s, 20s, and 30s series blinds is restricted to designated parking areas only. Attachment (5) provides a map of the parking areas as well as blind locations. People hunting together are encouraged to car pool due to limited parking in some of the hunting areas.
- b. Authorized parking areas (some blinds listed twice).
 - (1) Parking area (A) - Blinds 22, 25-26 (only one vehicle allowed);
 - (2) Parking area (B) - Ditch Road; Blinds 11-14, 15, 15A, 27, 30
 - (3) Parking area (D) - Beach Road - Blinds 15-17 - see note in paragraph below.
 - (4) Parking area (E) – Blinds 17-18, 27, 30-36, 39, 70-73, and shooting location 75.
 - (5) Parking area (F) - COTR pad for blind 10
 - (6) Parking area (G) – OLD GCA site for shooting area 74
 - (7) Parking area (H) – Shooting location 40 and 41
 - (8) Parking area (I) – Near tide gates for Eastern Shooting Area (ESA)
- c. Hunters shall not park in areas that would prevent employees from parking in their usual areas during normal working hours. Parking is not permitted on the roadways in front of blinds or in such a manner as to block roadways. Personnel parked in area D (Beach Road) or in the 40's parking shall move their vehicles, if a target launch occurs. All blinds except 40 and 41 are out of the target launch hazard pattern.
- d. Hunters will leave blind requests face up on the dash of their vehicles to aid Weapons department or Security personnel in identifying individuals and their locations, in case vehicles need to be moved or other emergency.
- e. Personnel repairing blinds before season or cleaning up afterward shall leave blind requests (completed but unsigned) on the dash with appropriate purpose for being in the restricted area in the "REMARKS SECTION". A large sign or note would also suffice.

9. Post-Season Cleanup. All blinds used for waterfowl hunting will be cleaned up within one month after the conclusion of the waterfowl hunting season, as coordinated by NBVC Environmental and the Waterfowl Hunting Committee. Bridges are not open to the public for recreational use after the season.


CHAPTER 3 – NBVC BLIND ASSIGNMENT PROCEDURES

1. Assignment of Hunting Blinds

- a. Hunters shall submit blind requests to the Environmental Division, or the designated drop box before 1100 each Monday. Hunters may email the form to NBVChunting@verizon.net before 0700 each Monday. Blind assignments are normally completed by 1300 each Monday unless it is a holiday, in which case blinds may be assigned on Tuesday. Approved requests can be picked up from the designated pickup box or have blind assignment number emailed back to the hunter (if an email address has been provided on the form – committee time permitting).
- b. Use the following procedures when blind assignment requests are submitted after 1100 on Monday:

- (1) Hunters will telephone the duty Waterfowl Committee representative at (805) 890-7245.
- (2) The Waterfowl Committee representative will verify the hunter's eligibility and blind request and verbally assign an available blind from the unassigned blinds using the weekly blind assignment sheet. The hunter will fill out a blind request and annotate the approval block with the words "assigned by telephone". He/she shall then use this form for filling out the bag record.
- c. The signature of a Waterfowl Hunting Committee member or the Environmental Division is required for all blind assignment requests unless assigned by telephone.
- d. Persons desiring to hunt together in the same blind should clip or staple their blind requests together. Only two persons are allowed in each blind unless approved in advance by the Waterfowl Hunting Committee. Enter such requests in the "REMARKS" section of the blind assignment request form. If more than two are approved, no more than two may shoot at the same time except in the ESA, where three are allowed to shoot due to increased space available.
- e. Blinds are assigned per the priorities listed below:
 - (1) Active duty military personnel
 - (a) NBVC and tenant commands; and
 - (b) All other active duty military (including Air Guard)
 - (2) Retired military personnel
 - (3) Department of Defense civil service personnel including
 - (a) NBVC and tenant commands;
 - (b) Mugu Alumni Association, China Lake and Vandenberg AFB
 - (4) Military Affiliated with ID cards
 - (a) Guard and Reserve military on Orders
 - (b) Dependents of active duty personnel over the age of 18 hunting without sponsor.
 - (c) Reserve military not on orders
 - (5) NBVC contractors (with NBVC badge) or veterans with service connected disabilities
 - (a) With NBVC Photo CAC ID card
 - (b) With NBVC DBIDS ID or VA Health Identification card which is registered with pass & ID)
- f. Most of the personnel listed in the categories above may be permitted to have up to two guests if the size of the assigned blind allows (see below). Attach the blind request(s), along with the full name of the guest(s), to the sponsor's request. An eligible hunter must accompany any guest at all times. The eligible hunter is responsible for the actions of his/her guest(s), including regulations observation and species identification. "Guest" shall be entered in the priority block. Guests must also take the complete test, and have a shotgun registration on file, i.e. complete all requirements except hunting area tour.
 - (1) Personnel sponsors who may escort guests through the gate without prior approval include active duty, retired military, current DoD employees, category (4a), category (4b), and contractors with a photo DoD CAC ID card (category (5a). The sponsor must accompany the guest at all times if they do not have a base badge.
 - (2) Personnel in categories (3b), (4c), and (5b) may have guests, only if they are "sponsored" by an appropriate sponsoring authority who will agree to provide the necessary paperwork to security in order to obtain a badge. It is the hunter's responsibility to find an appropriate sponsor. The eligible hunter must ensure the guest's data on the registration form is completely filled out. After the paperwork is submitted, the guest may pick up their badge at the Pt Hueneme badge office at the Knott (Sunkist) gate. Submission of data must occur at least five days before the guest intends to pick up their badge, so plan accordingly. An NBVC badge for waterfowl hunting will normally be issued for

only 5 months (Oct through Feb). The sponsor need not accompany a guest at all times if they have a badge, however that guest hunter must be accompanied by an otherwise eligible hunter (categories 1-5 above) in order to actually hunt.

- g. Personnel may volunteer to repair or construct blinds and/or bridges prior to the beginning of the hunting season (after August 1st of each year). Preferential blind assignment request slips (colored forms) shall be awarded to those individuals who participate in the repair or construction of blinds and/or bridges. Six preferential blind assignment request slips shall be issued to each hunter per season. These request slips MAY NOT be transferred to another individual. Additionally, for opening day hunting, personnel who repaired blinds are guaranteed that blind, if they so request and their request contains two preferential blind assignment request slips. After opening day, if personnel desire to increase the probability of getting their listed blind preference, more than two preferential blind assignment request slips may be used. For example, six preferential blind assignment request slips would be processed before five, and five before four. In this case, fill out the primary applicant's name on the preferential blind assignment request slip and any appropriate remarks on the top form only. See Attachment 7 for more detail. Appropriate remarks might include any restrictions on how you want to use the slips, i.e., "use the preference slips only if I get one of my first three blind choices".
- h. The Waterfowl Hunting Committee may revoke hunting privileges aboard NBVC, if a request for a blind is received that fraudulently indicates a priority category higher than appropriate for the requester or adds a request for another hunter who had no intention of hunting.
- i. Notify the duty Waterfowl Committee member as soon as possible at (805) 890-7245 of a cancellation of blind assignment so that the canceled blind can be reassigned.
- j. When a blind is assigned, the hunter can use it for the period of time indicated on the blind assignment form. If the assigned hunter leaves the blind and returns later, he/she still has priority for the assigned blind. Anyone using the blind while the assigned user is gone is expected to courteously and promptly vacate the blind.
- k. All complaints concerning the assignment of blinds shall be submitted to the Environmental Division.


CHAPTER 4 - COMPLIANCE

Violations of California or federal hunting regulations or provisions of this instruction shall result in revocation of shooting privileges. Personnel authorized to hunt waterfowl per this instruction are authorized to shoot only waterfowl as defined by the federal and California hunting regulations, with the exception of listed NBVC exceptions. If asked by any member of the Environmental Division, Waterfowl Hunting Committee, Security, CDO, CDFG Warden, Weapons personnel, or FWS Special Agent to present his or her blind request, hunting license, shot shells, or species of waterfowl taken, the hunter will comply or be considered in violation.

Any hunter who observes someone else violating the provisions of these instructions shall report the incident to the Waterfowl Committee or Environmental Division for appropriate investigation.

1. Protected Species

- a. Designation of hunting areas has been accomplished in such a manner as to minimize any potential negative impact to protected and endangered species found at NBVC. The Western Snowy Plover and the Light-footed Ridgway's Rail are protected under the Federal Endangered Species Act (Public Law 97-304, as amended by Public Law 96-159), the Federal Migratory Bird Treaty Act (16 U.S.C 703-712), and the California Endangered Species Act. The Belding's Savannah Sparrow is protected under the Federal Migratory Bird Treaty Act (16 U.S.C 703-712) and the California Endangered Species Act. Harbor seals

are protected under the Federal Marine Mammal Protection Act (Public Law 92-522, as amended by Public Law 100-711). Each of these laws prohibits the unauthorized harassment or killing of these protected species. The penalties for potential violation of these laws are as follows:

- (1) Federal Endangered Species Act, \$25,000 or one year imprisonment or both per violation.
 - (2) Migratory Bird Treaty Act, \$5,000 or six months imprisonment or both per violation.
 - (3) Marine Mammal Protection Act, \$20,000 or one year imprisonment or both per violation.
- b. Salt marsh birds-beak is a federal and state listed endangered plant protected under both the Federal Endangered Species Act and the California Endangered Species Act. All salt marsh birds-beak areas are delineated with flagging. Entrance to all salt marsh birds-beak areas is prohibited. The following conditions apply, if a downed waterfowl falls into a flagged area of salt marsh birds-beak:
- (1) Hunters shall use a pole to retrieve a downed bird, when feasible.
 - (2) If the downed bird cannot be retrieved with a pole, the bird shall be retrieved with minimum impact to the flagged area. The hunter is permitted to carefully enter the area to retrieve the downed bird. The hunter shall enter and leave by the same path. The path shall be the shortest path possible.
 - (3) NBVC Environmental must be contacted by the first working day after entry.
- c. All hunting blinds are evaluated annually, prior to the hunting season, to determine the need for closure because of potential impacts to endangered species.

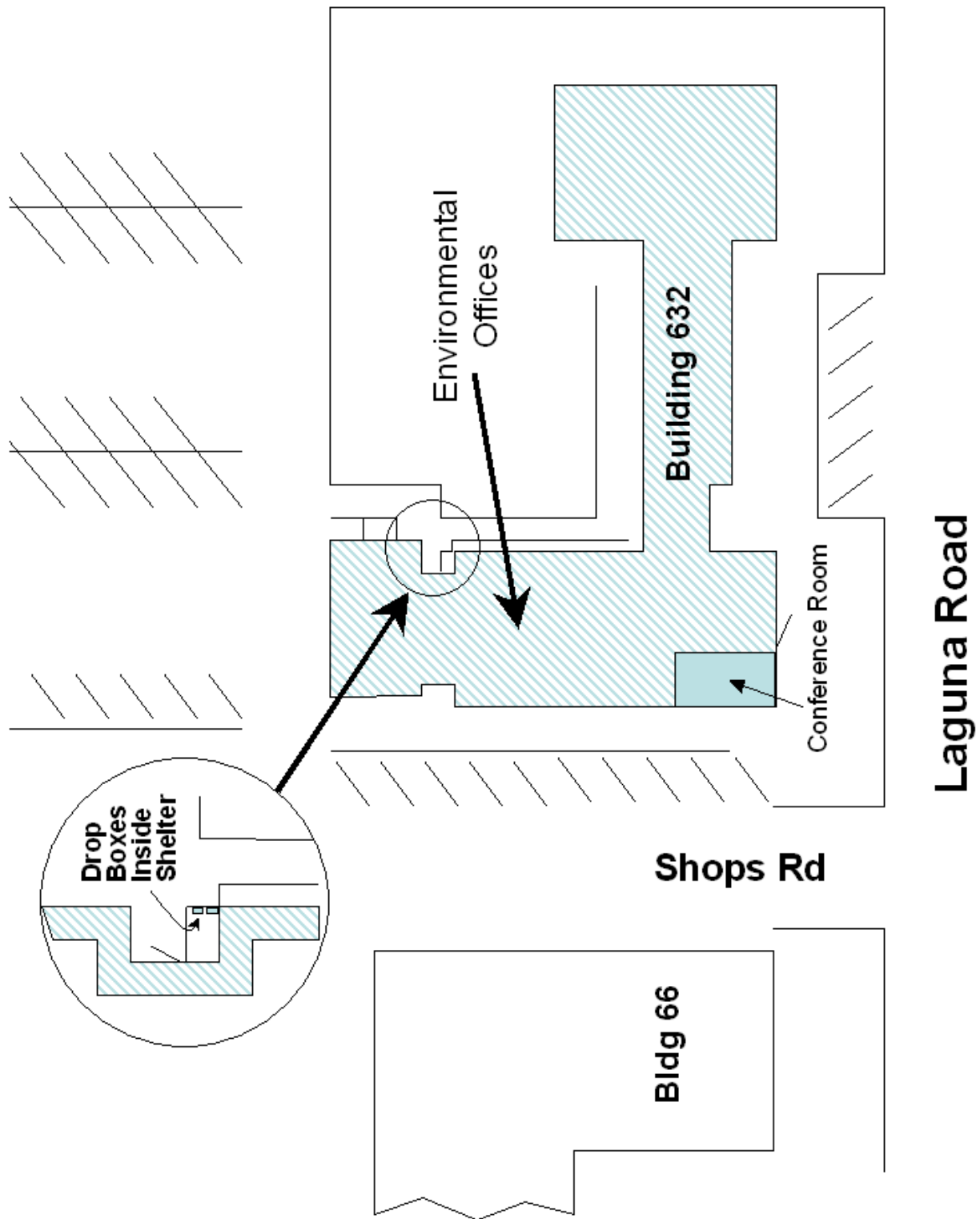
2. Non-Game Wildlife

- a. Shooting of the common snipe is prohibited because of its close resemblance to many protected shorebirds found in the lagoon.
- b. Shooting of non-game migratory birds is prohibited. There is high diversity and density of non-game birds that utilize the estuary, with some closely resembling waterfowl. Therefore, extreme caution must be given to ensure game species are properly identified.
- c. Shooting of mammals and other wildlife is prohibited.
- d. Coots are a waterfowl game bird and if shot, must be retrieved.
- e. Hunters are to report any accidental shootings of non-target species to the Environmental Dept Office at 989-3808

3. Effective Shooting Range

- a. Hunters shall not shoot waterfowl, unless within effective killing range, as crippled or wounded birds too frequently cannot be retrieved. If the hunter cannot retrieve a wounded bird, notify Environmental at 805 989-3808 with information on type of waterfowl and location last observed.
- b. The maximum effective range for most hunters with steel shot is 30-45 yards, which also allows for positive species identification, improved shooting, and more ducks.
- c. While guns and ammunition may be capable of killing at longer ranges, the shot pattern is diffused and usually ineffective. "Skybusting" beyond the recommended limits, spoils the hunting for everyone. This is especially important while using steel shot.

(1) Check out radio – this is best done the day before - although ET Shop is open 7 days a week, the duty person may have to be called by cell after 1600.

(2) Duty Cell 805-797-5807

(3) Log radio out, using with your name & phone # in the log book & "WF Hunter, Blind xx", for dept/div

(4) Go to your blind and check in with tower after 0630 "Tower, Duck Hunter in Blind xx checking in"

(5) If tower broadcasts "99 blah blah blah", that means the message is intended for everyone, i.e. "99 duck hunters vacate blinds within 10 minutes". You must go at least as far as perimeter road.

(6) If asked to vacate for a takeoff or landing you may ask tower if/when you can return.

(7) If you accidentally change the radio, it is on channel 1.

(8) Turn in radio when done hunting

SAFETY BRIEF FOR CIVILIAN PERSONNEL, MILITARY AND VISTORS

1. All personnel who are entering the Point Mugu Explosive Hazard Area for waterfowl hunting shall adhere to notes 2 and 3.
2. Smoking is not permitted in or around Ordnance Magazines, Ordnance transportation routes, Ready Service Lockers, and Ordnance Assembly Facilities.
3. Radio and/or Cell Phone transmissions are prohibited inside the explosive hazard area unless approved by the Installation Explosives Safety Officer.
4. Parking of POV's shall be safely parked off the side of the roads and shall not block the entry or exit gates, i.e. Bldg. 88, parking area B on Ditch Road.
